MESSAGE FROM THE TRUSTEE



We look back on 2013 with mixed emotions. 2013 commenced with the loss of our friend and Board Chair Dr Christopher Peters AM OI. As Trustee I speak on behalf of current and past board members, staff of the Public Trustee and also the many people who may have benefitted from the good work facilitated by Chris through GreaterGood. At GreaterGood, we had Chris in our lives for only a short part of his life but for lasting effect.

It is through the excellent work of all of these people and through the judicious planning of those that have established philanthropic funds in GreaterGood, that GreaterGood achieved a corpus during the year of \$11.4M before distributions, an increase of \$1.4M over the last year.

Mr Larry King, Executive Director of the ACT Law Society was appointed as Chair of the Board in June 2013. Larry has been a Board member for several years and was instrumental in founding the ACT Law Society Foundation at a function held at the ACT Legislative Assembly. The function was addressed by Attorney-General Simon Corbell MLA, Hon. Justice Patrick Keane QC and ACT Law Society President Noor Blumer. It was also pleasing to have our patron Lady Helen Deane and Canberra Centenary patron Sir William Deane present as well as past Chair the Hon. Margaret Reid OAM. The Foundation will seek to bridge opportunity gaps in the Canberra Community.

GreaterGood ended the year on a high with a record \$505,814.37 distribution. GreaterGood was also entrusted with accounts for the National Arboretum and the Capital Woodlands and Wetlands Trusts as well as a number of new accounts bringing the total to 65 funds.

The Public Trustee, has complied with the requirements of the Australian Charities and Not For Profits Commission established in October 2012 in particular the requirement to distribute 4% of annual income for both the Gift Fund and the Open Fund.

On the advice of the ACT Auditor-General at the close of the last financial year, GreaterGood accounts will no longer be separately reported in the Public Trustee's Annual Report and will be included in PTACT's Trust Account financial statements.

Our own workplace-giving scheme JACS4GreaterGood will achieve a corpus of \$100,000 during August/September. Following a survey of contributing staff, the Boundless Playground Project Canberra was unanimously selected as the charity to receive the 2012-13 distribution of \$2,350. A presentation was made by Justice and Community Safety Director-General Kathy Leigh to the Community Services Director-General and Boundless Project Director Natalie Howson at the JACS Trivia night on 23rd August at the JACS Trivia Night. This project was a fitting recipient given its plan to be funded by ACT public servants.

It was a particular pleasure to staff of the Public Trustee that Doug Gillespie, Deputy Public Trustee and founder of GreaterGood received the ACT Government Service Award in the "Respect" category recognising his remarkable efforts and foresight in setting up and driving the development of GreaterGood since 2003.

I look forward to the next exciting chapter in our development.

He also founded the Indigenous Business Chamber of Australia and was awarded 2012 Canberra Citizen of the Year. Chris was also honoured with a plaque in the ACT Honour Walk in 2012. Chris's life was celebrated at a Memorial Service held at the Albert Hall on Friday 12 April.

FOCUS ON

THE ERIC CRAWFORD MEMORIAL FUND:

Eric Joseph Crawford was born in Sydney in April 1925. He was born to William Sinclair Crawford an Engineer and Maud Crawford. Eric grew up in Marrickville. He did a school apprenticeship as a toolmaker machinist/Fitter and joined the Defence forces – RAAF in May 1943 as a trainee Technician. During his first year of service, he served at many RAAF bases throughout Australia. In 1944, he was posted overseas to a repair and servicing Unit in Milne Bay. Eric returned to Australia in 1945 and was discharged in February 1946. He re-enlisted in March 1950 as a Flight Rigger at RAAF Richmond, East Sale. His final posting was to Laverton where he was discharged in July 1952. For his service to the RAAF he was awarded the Star-Pacific Star War Medal, the Australian Service Medal and the Active Service Badge. During his active service, Eric was wounded and faced many years of pain and suffering caused by Osteo-arthritis in the knee and hip of his left leg which also affected his back. William Crawford passed away in 1956. Eric was affectionately known as 'Ecker' by his friends and he never complained or sought sympathy for his problems. He preferred to participate in his passion of fishing for black fish in the Tuross River and supporting his favourite footy team the Dragons. Eric never married or had any children, he quietly donated to various charities over many years and he loved children, dogs and a good cold beer and an even better yarn. In 1974, Eric agreed to the amputation of his left leg below the knee. Unfortunately when hospitalised the surgeons removed the wrong leg which left him to continue his suffering as he then refused to allow the surgeons to remove his left leg which would have made him a paraplegic. As a result he was classified as TPI. Eric lost his mother Maud, in a car accident in 1978. For the next 30 years Eric lived out his life at Tuross Heads passing away at the age of 79 in July 2004. In 2002, Eric drew up his Will and elected to establish the Eric Crawford Memorial Fund on his passing. The Spastic Centre, now known as the Cerebral Palsy Alliance and the Royal Blind Society who merged with Royal Victorian Institute for the Blind and the National Information Library Service and Vision Australia to become known as Vision Australia, were to be the beneficiaries of his annual income distributions from his fund. Since his passing his two charities have received \$408,353,62. Over the years the funding has been used to purchase computer software applications to assist visually impaired people, assisted in the "Get Out There" program aiding disabled youth aged between 14-18 years of age and enabled disabled people in Canberra and the surrounding region to be involved in regular recreational activities and live a more well balanced lifestyle. Eric is remembered by a plaque in the ACT Garden of Remembrance Woden Cemetery as Badge number RAAF 134372 LAC but he is remembered by many more people for his generous philanthropic nature which will continue into perpetuity.

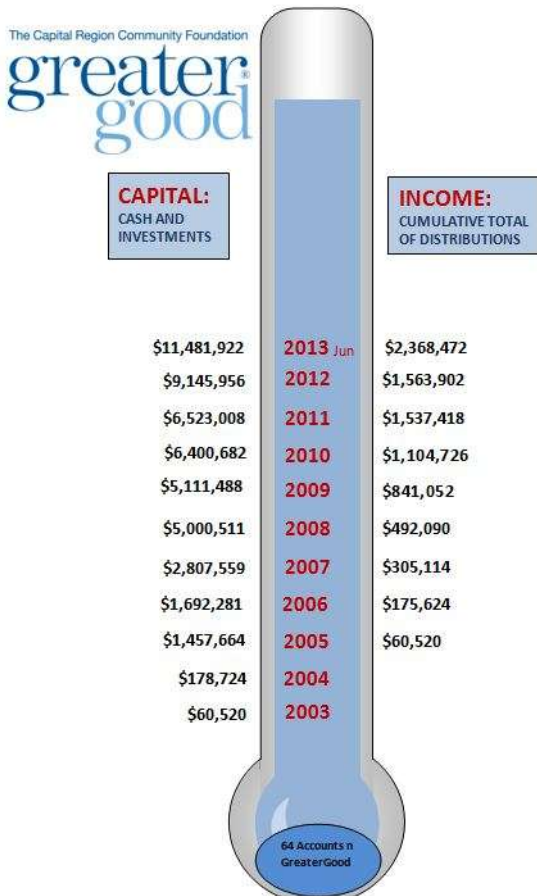

Youth - Outward Bound with GreaterGood

We like to hear positive stories of the younger generation in their development towards responsible adulthood and, during this current financial year, two charitable accounts within the GreaterGood Foundation, The Mundango Charitable Trust and the Bray/Kargas Charitable Fund, have combined resources to sponsor youth to attend the Outward Bound Navigator course.

These two charitable funds have been providing annual placements for selected youth from the greater ACT region in Outward Bound courses for the past eight years. Outward Bound's Youth programs aim to provide young people with the confidence, resilience and life-skills required to make their transition into adulthood. Courses provide outdoor adventures to youth to enable them to draw on their experience to survive and prosper through adversity. Outward Bound is non-profit and was formed seventy years ago based on navy observations that people with

life experience were better equipped to survive disasters at sea.

One of the recent course participants later said "The course would be the most amazing experience I have had so far in my life. I learnt amazing life skills that I will never forget, such as team work to achieve the target you are aiming for."

ACT LAW SOCIETY FOUNDATION ESTABLISHED.

At the launch of the ACT Law Society Foundation held on Wednesday 29th May, the Hon Justice P Keane QC, in launching the Foundation, said "The Law Society was to be commended for establishing the foundation as a focus for the commitment of the legal profession in the Territory to the public good and the welfare of the community. The Law Society is to be congratulated on taking positive steps to light a candle rather than simply to curse the darkness."

ACT Attorney-General Simon Corbell MLA noted that the Law Society has a long tradition of charitable fundraising through functions such as Law Week, and in previous years a different charity has been chosen each year to receive the funds. The Law Society has established the foundation to provide a more substantial and enduring expression of the ACT legal profession's connection with, and concern and support for, Canberra and its charities. Whilst it will begin modestly it will over time become something of which the members of the Society can be proud and which will contribute meaningfully to the welfare of our community.

The Foundation's initial capital will come from the proceeds of Law Week over the next three years, matched by funds from the Society.

On 19th March, as a part of Seniors' Week 2013, Belconnen Community Services held a Seniors Expo which highlighted the services provided by the organisation for the community. Static displays, exercise/movement classes and craft activities were scheduled throughout the day. The National Arboretum Canberra was conceived following the 2003 bushfires that devastated nearby suburbs and bushland. A national competition was held to create a design for the new National Arboretum and the winning entry of "100 forests and 100 gardens" was selected in 2005. The development encompassed a mosaic of permanent gardens, outdoor sculptures, cafe, visitors centre, Bonsai and Penjing display, children's garden and playground, pavilion and an outdoor events area.

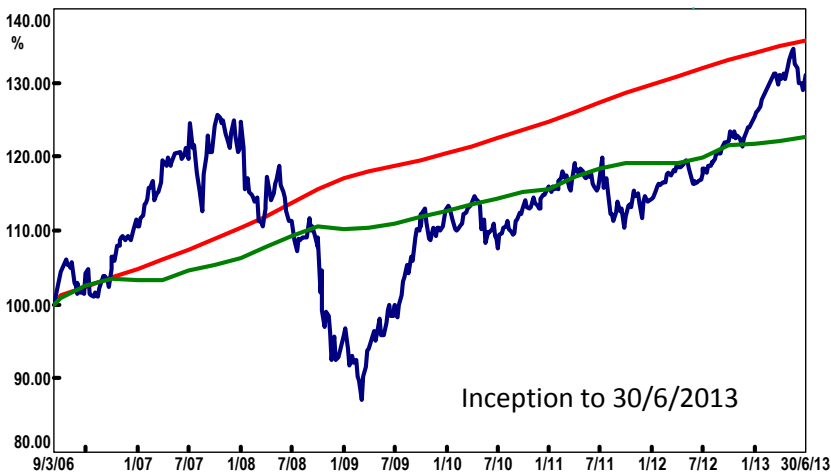
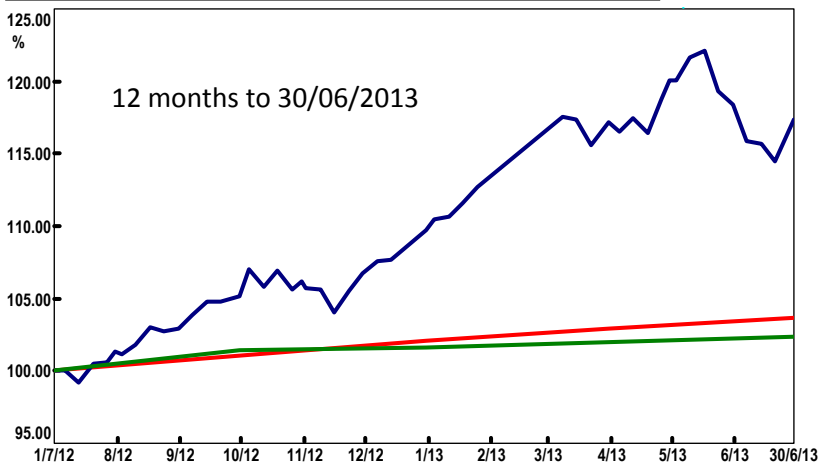
INVESTMENT PERFORMANCE OF GREATERGOOD FUNDS:

FOR THOSE THAT ARE INTERESTED IN HOW THEIR INVESTMENTS ARE GOING:

GreaterGood’s investment funds have achieved a strong positive result for the 2012-13 financial year. The Gift Fund’s Growth Investment Fund produced a total return of 17.51%, consisting of 13.81% capital growth from investment in the Australian share, fixed interest, listed property and international share markets, plus a 3.70% income distribution to Gift Fund accounts. Likewise the Open Fund enjoyed similar results of a 17.14% total return consisting of 13.76% capital growth and 3.38% distribution income.

Thanks to the income tax exemption status held by GreaterGood, all dividend imputation tax credits (also known as franking credits) will be claimed back from the Australian Taxation Office and added to the next round of distributions to GreaterGood accounts. Effectively this increases the above income distribution returns to 4.39% and 4.01% respectively.

To ensure the assistance that GreaterGood provides to charity is continued into perpetuity it is essential that the benefits GreaterGood provides are protected from inflation. This requires an investment strategy that will produce a capital growth return in conjunction with regular income for annual distributions. Returns will fluctuate from year to year, however longer time periods should come out stronger than capital stable investment strategies.

Capital Region Community Foundation Distributions for year ended 30 June 2013

Gift Fund:

Public Ancillary Fund (PuAF) Guidelines under the *Taxation Administration Act 1953* contain 57 items to guide PuAF administrators and Guideline No 19 provides for a minimum annual distribution of 4%. The opening equity in the Gift fund as per audited accounts as at 1 July 2012 is \$6,770,201 - (4% = \$270,808). The actual distribution was - **Income** to 30 June 2013 - \$248,146.46, **Capital** to 30 June 2013 - \$18,540.00 and **Accrued** distributions - \$5,580.00 totalling \$272,266.46, achieving the required 4% by \$1,458.46.

Open Fund

The Australian Charities and Not for Profit Commission (ACNC), has not confirmed the requirements of a percentage distribution. However, applying the same 4% ruling as above, the Opening Equity as 1 July 2012, was \$2,733,342, (4% = \$109,333.68) **Income & Capital** distribution to 30 June 2013 totalled \$204,934.64, exceeding the requirement by \$56,000.

DISTRIBUTIONS

GreaterGood has distributed over \$2,408,254.68 to date to local charities since its establishment in 2003. Distribution for the last 6 months of the 2012-13 financial year totalled \$390,258.02. There are currently 65 active accounts with a total of \$11,173,888.00 in the corpus. The Public Trustee takes every opportunity to promote GreaterGood and, where appropriate, generates media releases, publicity and photo opportunities.
