MESSAGE FROM THE TRUSTEE

At GreaterGood, we believe that affordable philanthropy should not just be within the reach of all members of our community but rather a way of life.

It is timely that the close of 2012 heralds our tenth year as Canberra's first and only public charitable foundation and we are pleased to bring you the second GGEnews for GreaterGood. I wish to commend and thank those in my office who had the foresight to establish GreaterGood. I also thank our Foundation Patron Lady Helen Deane, those who have established funds or contributed as a member of our Board as well as administrative staff.

From our modest beginnings in 2003 we have grown beyond all expectations to a corpus in excess of \$10M in 10 short years having distributed \$1.8M to charity, mostly in the Canberra region, in that time. Whilst most of our funds have been established as a direct offshoot of PTACT's traditional Wills and Estates business, GreaterGood has successfully branched out into other areas of philanthropy and community charitable benefit including scholarship funds, workplace-giving, Community and Environmental Funds.

2013 will herald the launch of the Chief Minister's Centenary Foundation, designed to mark the occasion of Canberra's 100 years and to emulate similar foundations in other capital cities including the Lord Mayors' Foundations in London, New York and Melbourne.

GreaterGood has influenced philanthropy practices in the ACT, by establishing perpetual giving funds that keep on giving and providing charities with a source of funds in addition to their usual fundraising. I pay tribute to the influence and work of our current board headed by Chair and ACT Citizen of the Year for 2012, Dr Christopher Peter AM OI. During 2012, the board has overseen our compliance with the new Public Ancillary Fund guidelines, distribution of \$400,000 in the community...our largest so far, establishment of the Chief Minister's Centenary Foundation, a function recognising the efforts of our past board members and ambassadors and the opening of 9 new accounts. GGEnews will be produced quarterly and future editions of this E-newsletter will bring you information and stories about the excellent work that our funds do in our community. In the forthcoming edition you will have the opportunity to subscribe via the GreaterGood website.

Dr Christopher Peters AM OI is Chief Executive of the ACT & Region Chamber of Commerce and Industry, a position he has held since June 1997.

He has previously held the following positions:

- Chief Executive of the Canberra-based Royal Australian Institute of Architects,
- Chief Executive of the Sydney-based Company Directors' Association and
- Foundation Executive Director of the Australian Institute of Company Directors.

Chris is a Chartered Director, Senior Fellow of the Corporate Directors Association, Life Fellow of the Australian Institute of Company Directors, Fellow of the Australian Institute of Management and Fellow of the Australian Society of Association Executives. He is Chairman of the Corporate Directors' Association of Australia.

Chris is on the Board of three statutory authorities (and Deputy Chairman of one), several public companies, a number of community organisations and several private companies.

Dr Peters was honoured with the award of Canberra Citizen of the Year for 2012 in recognition of his personal efforts and significant contributions to business/commerce, government and the ACT community.



Larry King has been the Executive Director of the Law Society of the Australian Capital Territory, since 1997.

MEET THE PATRON, TRUSTEE AND BOARD

Justice Richard Refshauge first practiced law in 1976 when he commenced his legal career as a barrister and solicitor in the ACT. In January 2008 his Honour was appointed a Judge of the Supreme Court of the Australian Capital Territory.

Prior to his appointment, his Honour had been the Territory's third Director of Public Prosecutions – having been selected to that position in 1998.

His Honour has enjoyed a long period in private practice, first with the then leading law firm Macphillamy Cummins and Gibson – becoming partner in 1981 and senior partner in 1992 - then Sly and Weigall and finally at Deacons Graham and James. His Honour took silk in 2000.

While in practice, his Honour specialised in litigation, including commercial litigation, administrative and constitutional law, reconstruction and insolvency, industrial law and criminal law. His Honour lectures in civil litigation at the Australian National University and has done so since 1986. In 2001 he became an Adjunct Professor in the then Faculty of Law of the Australian National University (now the College of Law) and in 2007 the Faculty of Law of the University of Canberra.



Renee Le Grande joined the Institute of Chartered Accountants in Australia in 2005 and was appointed as General Manager of the Institute for the Australian Capital Territory in 2007.

Her major role is to liaise closely and identify financial training solutions with Federal and State governments.

Much of Renee's working life has focused on shaping business solutions to government for over 25 years, turning ideas into practical workable outcomes as well as devising ways to foresee and manage problems.

Prior to her current role, Renee spent five years, as General Manager at Media Monitors and Director and also spent over 15 years at The Canberra Times, working in several senior management roles. With a strong government background she continues to administer and maintain relationships with state and federal departments and ministers.

Laurie Wilson is a journalist, communications consultant and President of the National Press Club of Australia. His company provides advice to a range of public and private sector organisations.

He began his career on The Canberra Times and is a former national political correspondent for the 9 Network, Canberra Bureau Chief for the 7 Network and Secretary of the Federal Parliamentary Press Gallery.

Prior to establishing his company, he held senior management and board positions in the media and public relations industries.



Doug Gillespie introduced the concept of the foundation to the Public Trustee for the ACT based upon his charitable experience in the private sector and has been instrumental in the creation of GreaterGood and development to its present sound position.

Doug is the Senior Deputy Public Trustee and currently Chairman of Trustees of the AFL Canberra Foundation. He is an Associate of the Executor and Trustee Institute, a member of the Financial Planning Association, a registered tax agent and holds a Graduate Diploma of Applied Finance and Investment.

Christopher van Leeuwen Asthma Foundation

Christopher died tragically at age 8 (1959 – 1967) and a memorial fund has been established by his family to provide asthma education and support to schools, children and parents so that no young lives are lost to asthma unnecessarily in the ACT.

It has been almost one year since the Chief Minister, Katy Gallagher MLA, launched the Christopher van Leeuwen Asthma Foundation at Duffy Primary School and we have already seen the benefit of more schools being able to access vital asthma training for staff.

As we move towards year two we are delighted to launch the next phase of the foundation, which will generously donate an *Asthma Emergency Kit* to primary schools receiving training from the Asthma Foundation ACT. This exciting initiative will ensure that the staff are not only informed about how to deal with an asthma emergency, but that they will also have quick access to the equipment necessary to provide asthma first aid to a student in an emergency situation.

The Asthma Foundation ACT would like to acknowledge the generosity of the van Leeuwen family, and in particular Christopher's mother Joyce, in establishing this fund and working with the Asthma Foundation to support people with asthma and their carers in the ACT.



Asthma Australia has developed Asthma Emergency Kits to provide basic equipment and instructions to assist someone during an asthma attack. BillBerry Blue Stocking Fund - Son follows a trailblazer.

Robin Brown, the principal of the BillBerry Blue Stocking Fund, has relived a journey that his late mother, Freda Cole undertook in April 1939 when she cycled with a friend from Worcester in England to Bergen in Norway. A diary that Freda wrote whilst on the ride mentions sightings of the Hitler Youth and of villages festooned with anti-semitic signs. These writings alluded to Freda possibly being a cycling spy, but alas Robin believes that she was adventurous and with an “internationalist” spirit fostered by her strong engagement with the Girl Guide movement.

In 1939 this Englishwoman already rode a motorbike so, traipsing across Europe showed more of her dynamic nature. Freda’s journey took her south through France and Italy and then up through Switzerland, Austria and Germany and on to Scandinavia. This journey required a visa to enter Germany which she obtained in London from the German authorities. They stamped the visa into her passport and validated it with a black ink swastika stamp.

Robin undertook part one of the journey in 2010 where he followed her route from Worcester to Switzerland. Robin left Australia on May 19 2012 to complete the final 3,500 km of the ride up into Scandinavia to the target of Bergen.

Robin’s bike named Hannibal III is a light weight, streamlined bike named after his mother’s bike called Hannibal II which had no gears and was twice as heavy as Robin’s bike. Robin safely completed the epic ride in 2 months and 2 days, a similar time to Freda and her friend Berry whose journey came to an end when Berry’s brakes failed whilst going down a hill and hit a wall, receiving severe lacerations to her face and upper body as well as concussion.

Robin established the BillBerry Blue Stocking fund in August 2011 and he will be distributing his annual income to assist young women in the Solomon Islands through the Solomon Islands Girl Guides. This fund provides a scholarship for students from rural communities to assist with the costs country students encounter in pursuing their tertiary studies. Victoria Corcoran was the recipient of the scholarship for 2012. The award is for academic merit and commitment to the ethos of the Australian Catholic University. Victoria is in her first year of a Bachelor of Education. She was also the recipient of a Catholic Education Office Scholarship and an early achiever's program recipient.

Justice & Community Safety Directorate Workplace-Giving Trivia Night

The Jacs4GreaterGood workplace-giving scheme was established in September 2008 and JACS employees contribute fortnightly to the fund. The balance of the account is currently over \$81,000.00. These contributions and monies raised from social events are invested and, the income raised annually is donated to local charities. The half time entertainment for the Trivia night was the presentation of a cheque for \$2,827.00 to Robyn Bloomfield, EO of Autism Asperger ACT. This charity was selected by majority vote in a staff survey. The \$4,100.00 raised from the Trivia Night will increase capital investment through the JACS4GreaterGood account generating further income for future distributions.

DISTRIBUTIONS

GreaterGood has distributed over \$364,000 to date to local charities. The largest donation was for \$110,382.00 which was the income distribution from the Prance Family Memorial Fund. This was distributed to 4 Charities, each receiving \$27,595.50. For many of our newer accounts, 2012 was the first distribution from their fund. Oncology Children's Foundation, RSPCA, Asthma Foundation, Lifeline, Cancer Council and the Salvation Army all benefited from these new accounts.
